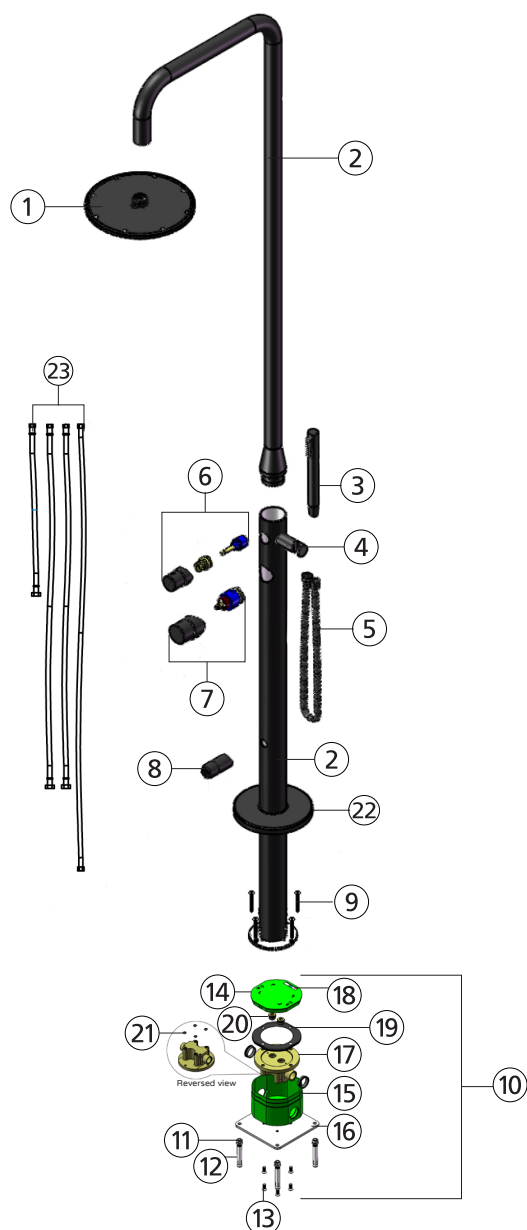

Masonry drill bit

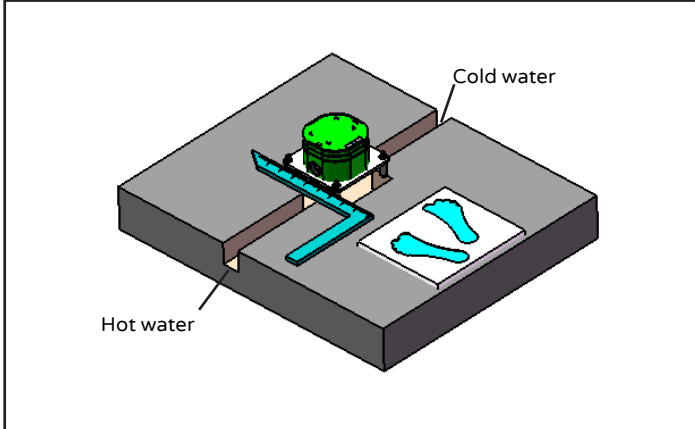

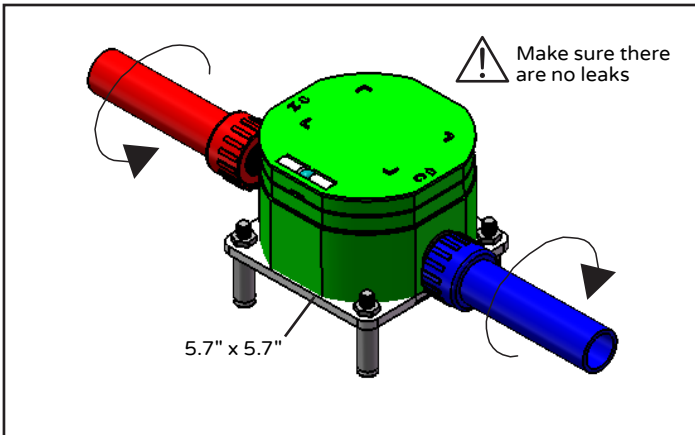
Installation Instructions

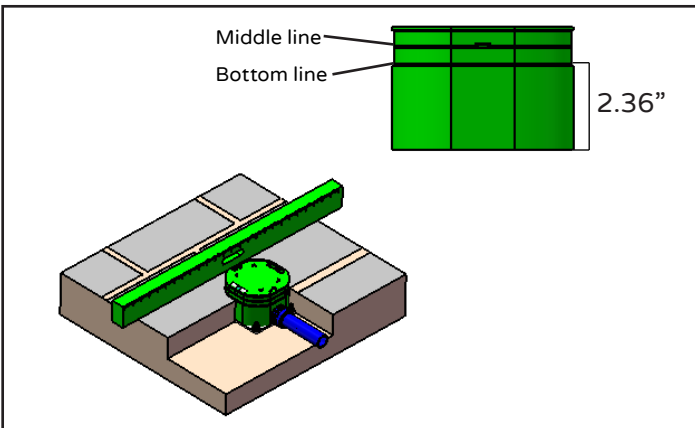
Confirm position for the mounting base (10) and standing place. Suggested distance between them is 30". Dig hole based on the mounting base (10) size.

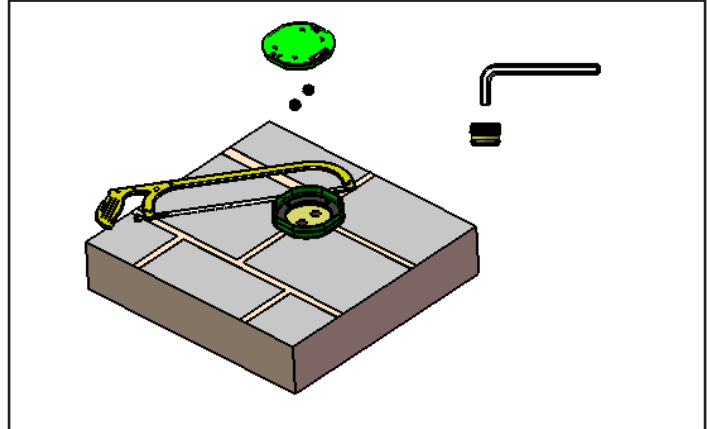
Connect hot and cold water pipes to mounting base (10).

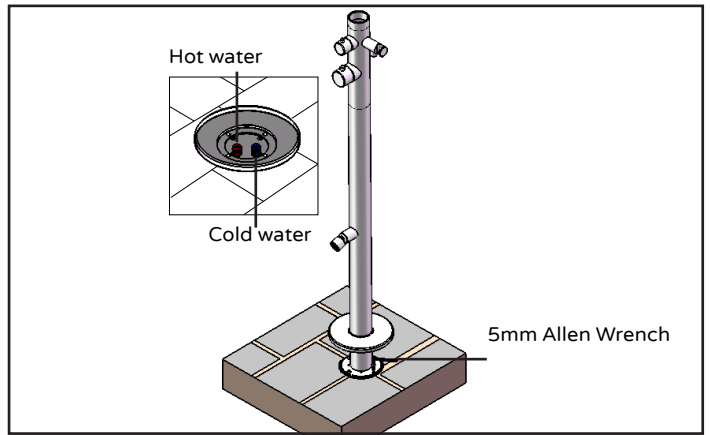
Make sure the mounting base (10) is vertical and centered to you. Tighten mounting base (10) with metal screws (11), make sure floor tile must be higher than bottom line and lower than middle line of mounting base (10).

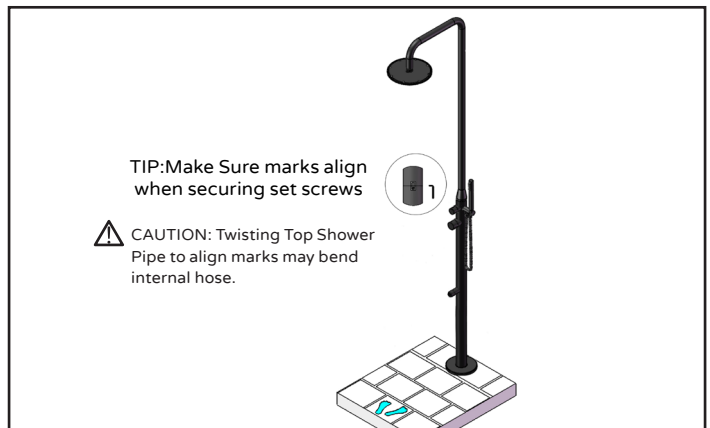
Discard mounting base cover and plugs for hot and cold water outlets. Cut the extra top part of the mounting base (10).

Insert bottom shower pipe (2) to the mounting base (10). Connect bottom flange to mounting base (10) with the four 5mm screws (6), then push down the bottom escutcheon.

Insert top shower pipe (1) into bottom shower pipe (2). Connect hex head end of hose to swivel joint and tapered end to handshower (4). Place the tapered end of the hose into the handshower holder (9).

CARE & MAINTENANCE

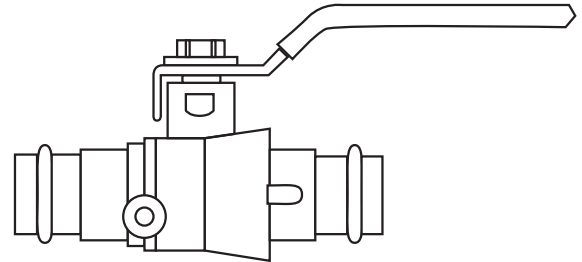
Always blot dry any water from the surface of your ShowerSpa. To help protect your ShowerSpa from hard water stains and mineral deposits, use an auto spray wax periodically and wipe down your ShowerSpa after each use. Allowing water to evaporate on the surface can lead to a buildup of mineral deposits. Cleaning with a damp, nonabrasive sponge and drying with a clean soft cloth should help keep your outdoor shower looking beautiful. Winter cover recommended included.

W A R N I N G

Warranty does not cover freezing. Please consult with a professional plumber if potential freezing can occur to install proper waste valves to drain system to prevent internal damage to the unit.

FREEZE CARE

We strongly recommend installing a 1/2" Full Port Press Ball Valve w/ Drain for areas affected by freezing weather.



MANUFACTURER'S LIFETIME LIMITED WARRANTY

1. Defects Covered; Warranty Period: Pulse Shower Spas, Inc. ("Pulse") warrants to the original consumer purchaser who purchases this shower spa (the "Product") for use in his or her own home, that the Product will be free from defects in material and manufacturing workmanship for as long as the original consumer purchaser owns that same home. For all other purchasers (including, but not limited to purchasers for industrial, commercial and business use), the above warranty will apply for a period of 5 years from the original date of purchase.

2. Remedy: If the Product does not conform to the above warranty, Pulse, at its option, will repair or replace the Product, free of charge, or refund your purchase price. For warranty claims, please visit www.pulshowerspas.com/index.php/warranty. Pulse may require that you return the Product to Pulse, shipping prepaid, in which case Pulse will provide you with a return materials authorization number (RMA). Pulse may also require that you provide evidence of the date you purchased the Product. Pulse will ship a new or repaired Product to you, at the expense of Pulse, or refund your purchase price. Service labor performed by you or others in connection with the removal or replacement of the Product will not be reimbursed by Pulse.

3. Exclusions: Pulse shall not be responsible for failure of the Product, and the above warranties will not apply, if the Product fails as a result of improper installation, improper use, modifications or repairs by anyone other than Pulse, or accident or abuse (including damage during shipment).

4. Warranty on Repairs and Replacements: For consumer purchasers who purchased the Product for home use, repaired or replacement Products will continue to be covered under this warranty for as long as he or she owns that same home. For other purchasers, repaired or replacement Products will be covered for the balance of the original warranty period.

5. No Other Warranties; Limitation of Liability: OTHER THAN THE LIFETIME LIMITED WARRANTY STATED ABOVE, PULSE DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, TO THE EXTENT PERMITTED BY APPLICABLE LAW.
